It is available on channel 16 or 116 (depending on the customer's language preference).

It also brings extra LIVE coverage of snooker, tennis Grand Slams and international prestigious competitions. Eurosport 2 is available on channel 31. With Eurosport 2 in addition to Eurosport 1, Eleven 1 and 2, Orange proposes the largest sport offer in Belgium, without having customers paying extra.

Eurosport 1 and Discovery which were already available in Flemish are now also available in French. Eurosport FR on channel 30 or 130, Discovery FR on channel 21 or 121 (depending on the customer's language preference).
