



JJ's Turf Rewards Program - Percentage Discount

Terms & Conditions

- The terms and conditions below and any revisions or amendments thereafter (the "Terms & Conditions") imposed from time to time by the Jebsen & Jessen Technology & Irrigation Group ("JJ T&I") shall apply to the JJ's Turf Rewards Program (hereinafter referred to as the "Rewards Program").
- The Jebsen & Jessen Technology & Irrigation Group consist of Jebsen & Jessen Technology Pte Ltd, JJ-Pun(S) Pte Ltd, PT. Jebsen & Jessen Technology Indonesia, Jebsen & Jessen Ingredients Vietnam Co. Ltd, Jebsen & Jessen Technology (T) Ltd and Jebsen & Jessen Malaysia Sdn Bhd. The JJ's Turf Rewards Program is a regional program that will be run in Singapore, Malaysia, Indonesia, Vietnam and Thailand ("Qualifying Countries").
- To be eligible to participate in the Rewards Program and for a customer to qualify for a discount, the customer must meet and continue to meet at all times, all of the requirements set forth in the Terms & Conditions.
- Failure to meet the requirements or failure to comply with any of the Terms & Conditions will result in the customer not being entitled to any discount it would have otherwise earned under the Rewards Program and also, JJ T&I shall have the right to terminate without notice to the customer, the customer's participation in the Rewards Program.
- Failure by any customer to provide true and accurate information when participating in the Rewards Program will result in the customer being automatically disqualified from the Rewards Program and all the customer's discounts that the customer had earned shall also be automatically void.

Program Period

- The Rewards Program shall commence on 1 October 2021 and shall continue until 31 December 2022 (the "Program Period").
- Notwithstanding the aforesaid, JJ T&I reserves the right to, at any time and at its sole and
 undisputed discretion, (a) shorten and/or extend the duration of the Program Period and (b)
 discontinue the Rewards Program, without any prior notification and without incurring any liability
 whatsoever.

Qualifying Purchases under the Rewards Program

- The Rewards Program will only encompass Qualifying Purchases made in the Qualifying Countries.
- Qualifying Purchases shall mean the purchase of all genuine parts, based on order value, directly from JJ T&I ("the Qualifying Products") and invoiced at the price sold by JJ T&I.
- Genuine parts refer to wear and tear parts and consumable items, which include equipment parts, vehicle parts and irrigation parts, but with the exception of any range of Lead Acid Batteries for Golf Buggy/ Utility Vehicles such as Rocket Battery, JCI Battery, Trojan Battery.
- Irrigation parts refer to parts listed in Toro, Aguamaster and K-Rain's official product parts books.





- For the avoidance of doubt, all finished goods, attachments and/or complete assembled products are not categorized as parts and are thus not eligible as Qualifying Products for the Rewards Program.
- Notwithstanding the aforesaid, products that were purchased on promotion, or for which a discount was given by JJ T&I will not be considered Qualifying Purchases under the Rewards Program.
- Also, only the final purchase price of the Qualifying Purchases will be used for computing the (total) purchase value by the customer under the Rewards Program. Final purchase price shall mean the price of the Qualifying Products less product returns, price protection plan purchases, taxes, handling and purchasing charges, freight insurance, other customer payments, duties, and excises.

Percentage Discounts

- The amount of discount a customer may be entitled to will be based on the accumulated purchase value of Qualifying Products by the customer over three months (one quarter). The percentage of the discount will be based on the table set out below
- All discounts earned are to be applied by the end of the following quarter by the customer on Qualifying Products to be purchased directly from JJ T&I. If the customer does not make any purchase during the next three months after earning the discount, then the discount shall be automatically void and of no further effect.

- Purchase value will restart from zero on the first day of the next quarter. Whatever Qualifying
 Purchases that were made in one quarter cannot be brought forward or added or in any way included in
 the next quarter.
- The cancellation of any purchase order by a customer will void the customer's eligibility to receive a
 discount under the Rewards Program. If a purchase order is cancelled after the customer has been
 given the benefit of a discount under the Rewards Program which the customer would not have been
 eligible for if not for the cancelled purchase order, then the discounted amount shall be a debt due and
 payable by the customer to JJ T&I.

Credit Standing

- To qualify for and remain in the Rewards Program, a customer must be in good credit standing and also ensure there are no overdue accounts receivable above 60 days for each individual invoice issued by JJ T&I.
- Failure to comply with the aforesaid will entitle JJ T&I to void any discount that the customer could have
 or has earned and will also result in the customer being disqualified automatically from the Rewards
 Program.

Additional Terms and Conditions

- JJ T&I reserves the right to without incurring any liability whatsoever, alter, amend, or cancel the Rewards
 Program or these terms and conditions at any time with or without notice to the customer upon the
 occurrence of any event(s) or circumstances beyond its reasonable control which may hinder, prevent or
 affect (or may likely to have such effect) the fulfilment of the terms of the Rewards Program including,
 without limitation acts of God, natural disasters or catastrophes, riots or wars (whether declared or not),
 terrorist activities, epidemics, health threats, quarantine requirements, change of any applicable laws and
 issuance of new applicable laws.
- All customers participating in the Rewards Program agree that neither JJ T&I, JJ T&I's parent company, its subsidiaries and affiliates nor any of their employees, directors, officers, agents and assignees shall be liable in any way for, and shall be indemnified and held harmless fully and effectively by each customer against, any and all injuries, losses or damages to property or person of any kind, including death, claims, actions, proceedings and other liability arising out of or caused in whole or in part, directly or indirectly, by the participation in the Rewards Program.
- By participation in the Rewards Program, each customer agrees to be bound by JJ T&I's terms and
 conditions herein or such other rules and regulations and any amendment or revisions issued thereto
 from time to time, as imposed by JJ T&I or any other relevant authority. Each customer shall also be
 deemed to submit to all decisions of JJ T&I, which shall be final and binding on all matters relating to the
 Rewards Program.
- The Rewards Program shall in all respects, be governed by the laws of Singapore. These terms and conditions herein are not intended to confer rights on any third party, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap 53B) or otherwise, and no third party shall have any right to enforce any of the terms and conditions herein.
