Liège-Louvain-la-Neuve, August 29, 2019 - Smartnodes proposes a breakthrough innovation in public lighting solutions. Smartnodes creates a light bubble that perfectly fits in size and light intensity around the user (pedestrian, bike, car). The control of this light bubble is dynamic, decentralised and locally distributed.

The start-up and Smart Cities communities have awarded Smartnodes numerous **international rewards**, highlighting its pioneering role in **sustainable urban development**: cities are saving on their public lighting energy consumption, while preserving road safety and improving the quality of life of citizens. With a global coverage of the public space, the public lighting network, equipped with new sensors, becomes the backbone of "Smart City" infrastructures and networks, the core business of Smartnodes.

The creation of Smartnodes dates back to October 2014, as a result of a development project initiated by the public sector (SPI) together with the academic world (ULiège and UCLouvain) from 2011 to 2014.

At the time of its creation, its financing was achieved in record time: thanks to their expertise in the creation of innovative companies, VIVES and NOSHAQ provided state-of-the-art support to the founding team together with the support of the incubator techno-entrepreneurs (WSL). Seed capital of about one million euros allowed to attract an experienced CEO, Jean Beka, alongside the inventors of technology, Professor Jacques Destiné and three researchers. Smartnodes started its activities with a big project launch (Village Expo of the City of Wavre) and many pilot sites in Belgium. The start-up was also able to benefit from research aid from the Walloon Region (DGO6).

In 2016, existing investors, joined by QBIC, accelerated the international development of the company through a capital injection of about 2 million euros.

A new growth phase via export is now opening for Smartnodes thanks to its integration within the industrial and European LACROIX Group, which decided to maintain the existing 15-people team in Liège and ensure local anchorage.

Philippe Durieux, CEO of VIVES: « After 5 years, the investors VIVES, NOSHAQ and QBIC, with the support of GESVAL, WSL and SPI, have put a spin-off originating from inter-university research into a further dimension. The takeover by an industrial actor like LACROIX Group is obvious to accelerate the commercial development of Smartnodes in a sector where critical size is essential. The cultural proximity between the two companies and the complementary skills are a guarantee of success for a rapid deployment of Smartnodes products. This test case illustrates our ability to create innovative start-ups and generate returns for our shareholders. »

Jean Beka, CEO of Smartnodes: « We are excited with this acquisition. Our skills were recognized by the LACROIX Group management team and Liège becomes the group competence centre in connection with the Smart City and its commercial base for Northern Europe. In addition, we immediately benefit from the excellent reputation of this group within cities and towns, which perpetuates our commercial offer. »
