Dear Attorney General:

Your recent appointment of two former Conservative political staffers to the nonpartisan, neutral Judicial Appointments Advisory Committee is an alarming affront to legal and democratic norms and must be reversed.

As University of Waterloo Professor Dr. Emmett MacFarlane recently stated, "I'm not sure I've ever seen such blatant examples of patronage recently."¹

Earlier today, Premier Doug Ford revealed that these appointments were a deliberate attempt at politicizing judicial appointments, saying, "We got elected to appoint like-minded people...I'm not going to appoint some NDP or Liberal. I've made it very clear where I stand on judges...You voted a party in...I'm putting like-minded people that believe in what we believe in...I'm gonna continue doing it."²

Minister, as alarming as it is for this Premier to be ignorant of basic legal and democratic norms, you are a member of the Law Society of Ontario and have a responsibility as a lawyer to conduct yourself in a manner consistent with *The Rules of Professional Conduct*. These rules include ensuring there can be no reasonable perception of bias, and appointing partisan actors to the Judicial Appointment Advisory Committee for inherently partisan political reasons, as stated by the Premier, is unacceptable.³
