NEW YORK, NY (September, XXX 2025) – The Starfish watch is a highlight of Blue Book 2025: *Sea of Wonder*, a collection born from a deep dive into both Tiffany’s archives, particularly the work of Jean Schlumberger, and the world’s oceans.

This limited-edition Starfish watch pays homage to the visionary designs of Jean Schlumberger, one of the 20th century’s most celebrated jewelry designers. It draws direct inspiration from an iconic pearl and diamond Starfish brooch found within The Tiffany Archives. The design reimagines the starfish motif through a contemporary lens, showcasing Schlumberger’s signature blend of naturalism and abstraction. It captures the essence of the starfish in a modern and elegant way.

The dial features two rotating starfish and a diamond outer ring, a whimsical touch that creates a dynamic and eye-catching display.

Showcasing Tiffany & Co.’s legendary expertise in diamonds, the watch case is fully snow-set using round full-cut diamonds of different sizes to create an almost unbroken expanse of light and reflection, with minimal visible metal. Adorned with a total of 891 round brilliant diamonds of nearly 6 total carats, the watch embodies Tiffany’s dedication to exquisite craftsmanship and the use of the finest gemstones.

A fine Swiss-manufactured self-winding movement powers the 39 mm model, which has a classic time-setting and winding crown. The design of the crown was inspired by the iconic Tiffany® Setting, made famous by the House’s diamond solitaire engagement rings, and features a prong-set solitaire diamond of over 0.47 carats.
