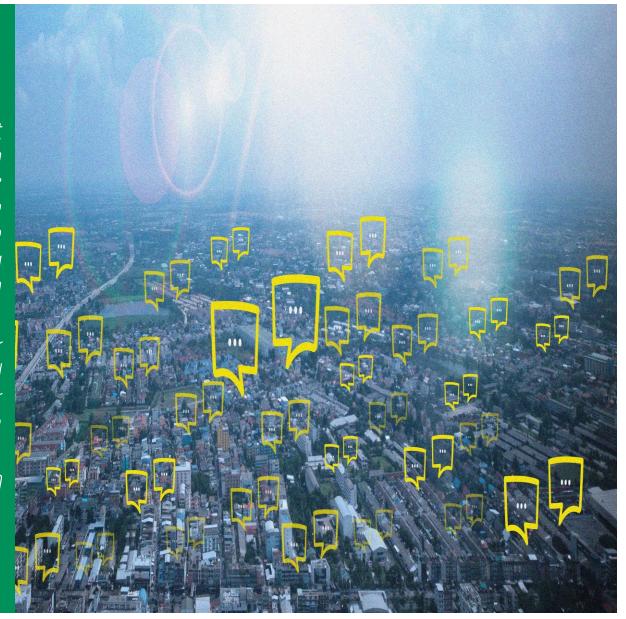

#### METHODOLOGIE

- Iwo years after the BNP Paribas Fortis Economic Research department conducted its first survey on digital preparedness, whose results were then published in a book entitled 'De Winnaarseconomie'/ 'L'Economie des Gagnants' ('The Winners' Economy'), authored by Chief Economist Koen De Leus, a second survey has recently been carried out. The same criteria were used for this follow-up survey as for the initial investigation, thus enabling conclusions regarding the state of digitalisation in Belgium to be drawn on an annual basis and direct comparisons to be made with the preceding year.
- The Economic Research Department carried out the survey in the last quarter of 2017 among a sample of 31 listed Belgian companies active in industrial and service sectors. We divided the survey up into these two categories in order to see whether the reaction function is different depending of the sector a company is in.
- The questionnaire sent out to the respondents contained a total of 10 questions formulated in English.

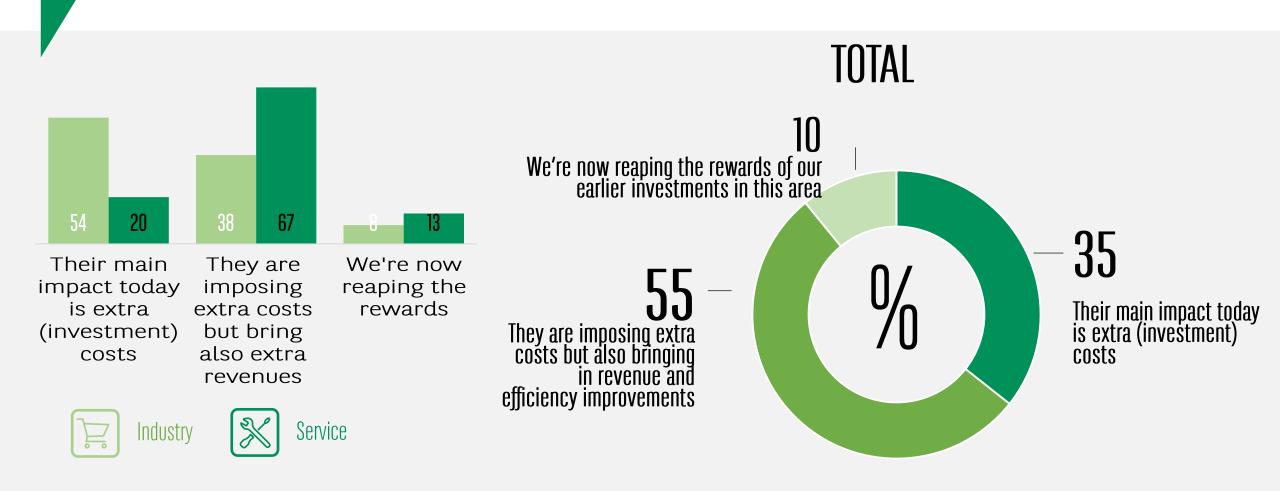
HOW WOULD YOU ASSESS YOUR PRESENT SITUATION?



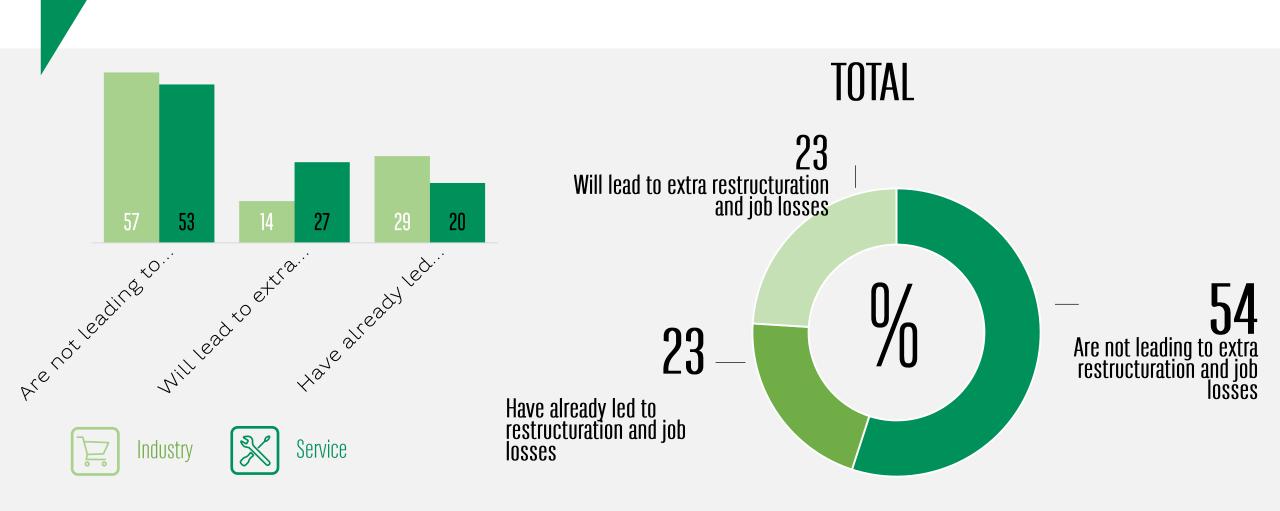

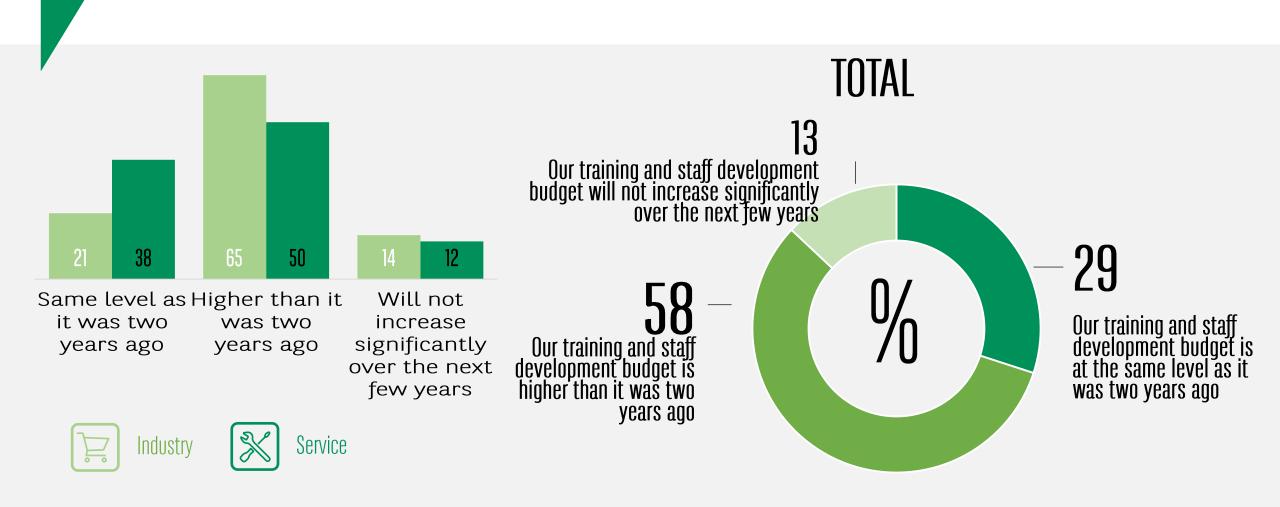

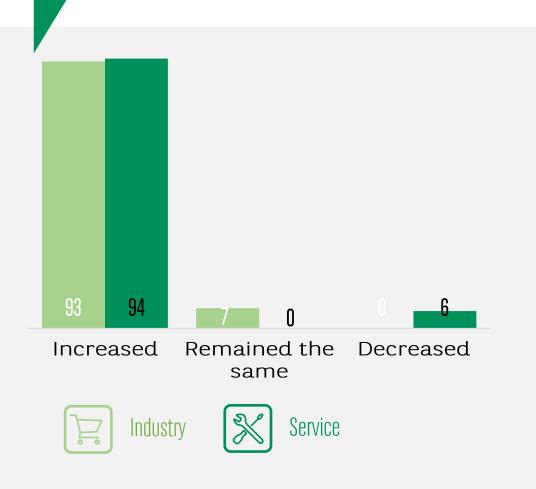

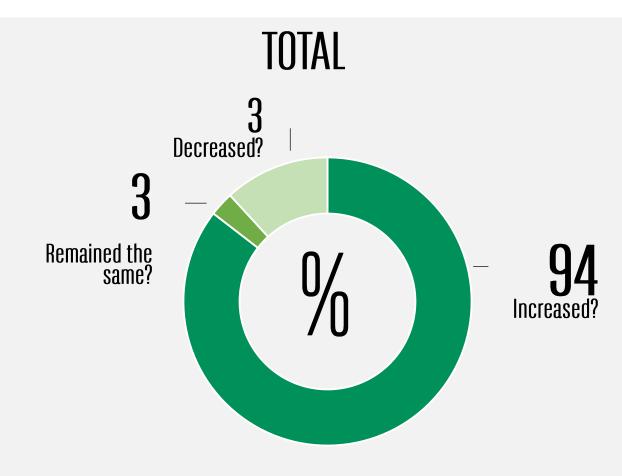


# 5. WHAT IS YOUR COMPANY'S APPROACH WRT LIFE-LONG LEARNING?

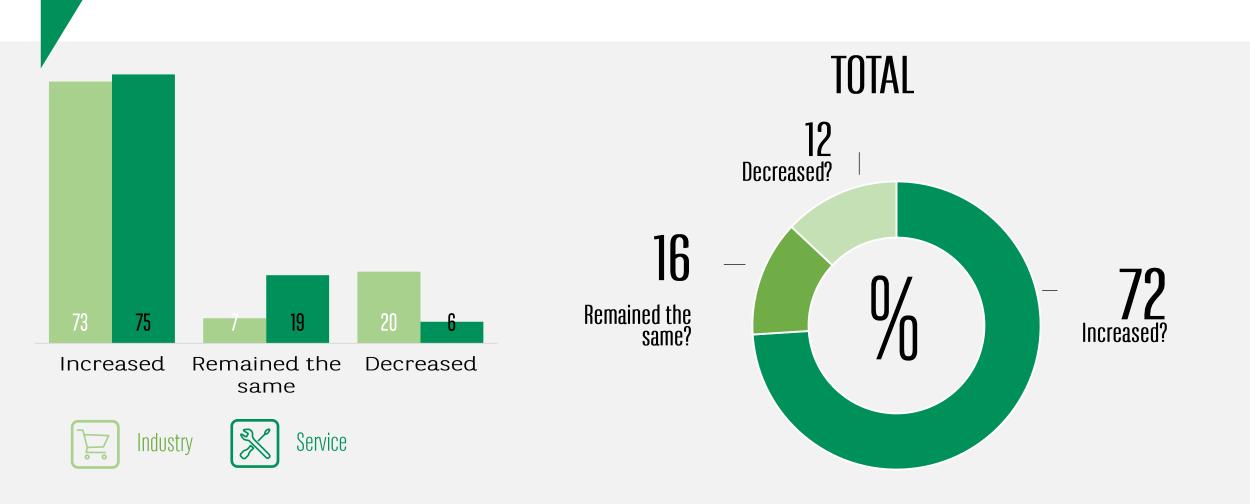


# 6. IN THE LAST TWO YEARS HAS YOUR IT PROJECT INVESTMENT BUDGET:

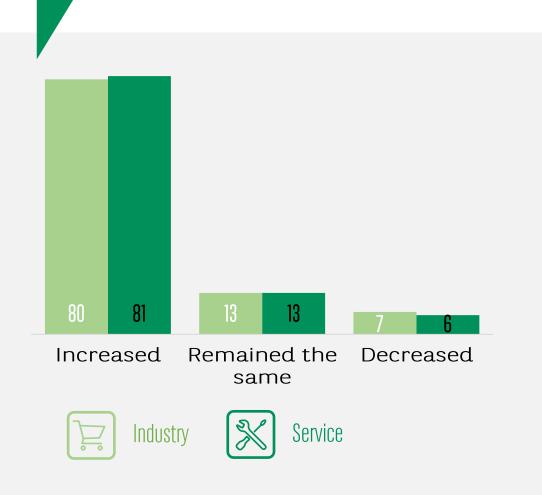


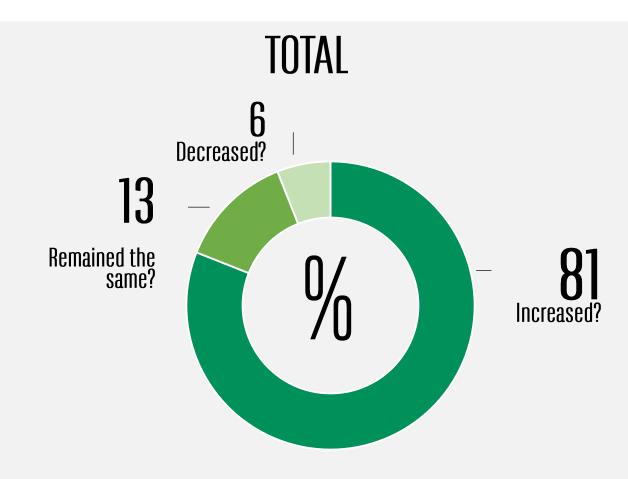

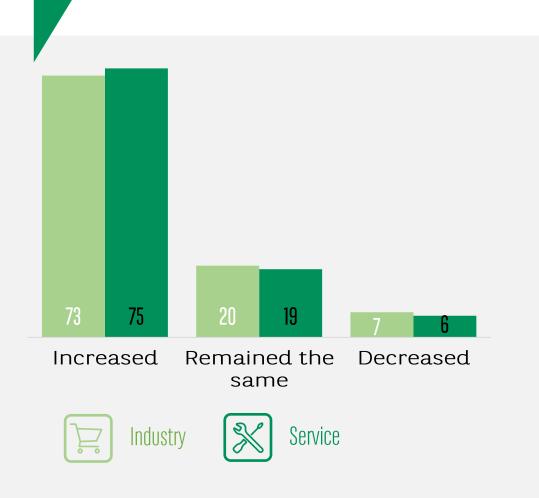


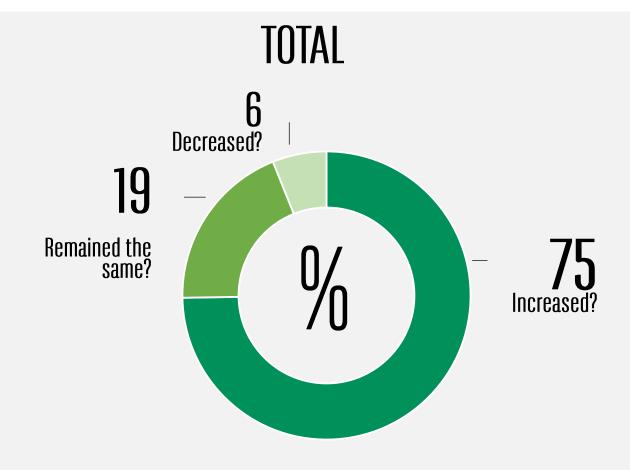

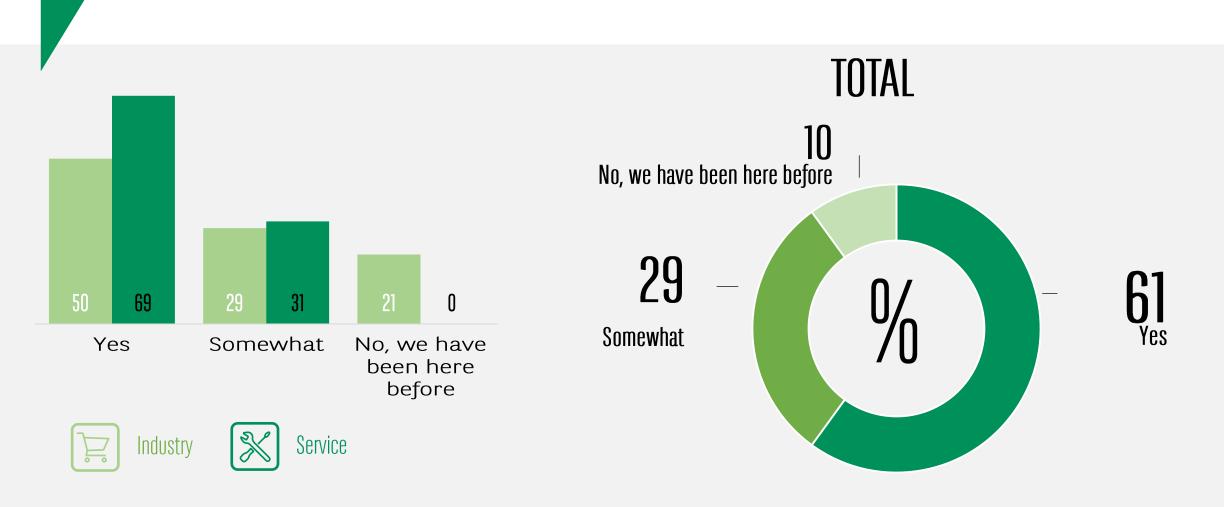
