Under the Share Repurchase Program 2016, as announced on February 10, 2016, the Company reports today that during the period from August 1 until August 3, 2016, the following transactions took place either through the regulated market of NYSE Euronext Brussels or through block trades in accordance with applicable regulations:

The Company currently holds 1,866,059 own shares (previous update on August 1, 2016: 1,838,607 own shares), representing 1.59% of the total number of outstanding shares (previous update on August 1, 2016: 1.57%).

All repurchased shares under the Share Repurchase Program 2016 (currently 1,100,000 own shares) will be held by the Company to cover the Company's obligations under existing stock option plans. As the Share Repurchase Program 2016 was authorized to acquire up to 1,100,000 shares, there will be no more transactions under this program. Including the share repurchases on August 3, 2016, the Share Repurchase Program was executed to the amount of €47,749,619. Hence, this is the last update on the Share Repurchase Program 2016.
