A few days later, WFO traveled to Bata, Equatorial Guinea, to clean Bome Beach with Centro La Fe, a school for people with hearing disabilities. Despite the beach's natural beauty, it was covered in litter from ocean waste and rivers carrying household trash.

With around 20 volunteers, we spent two hours cleaning up fishing nets, plastic bottles, and packaging. This effort was made possible by sponsors like Papier-mettler, whose recycled plastic bags we used.

Equatorial Guinea lacks a strong waste management system, so most waste is burned rather than recycled. However, the NGO De Gracia Recibisteis is making a difference by collecting, separating, and recycling local waste into beautiful products like handbags and water fountains. Their center also educates the community on recycling and reusing items. Witnessing their creativity and impact was truly inspiring!

## **Equatorial Guinea -** Clean-ups

In the continuation of our African roadshow, WFO travelled to Equatorial Guinea where we organized two clean-ups and visited a local recycling initiative. Our first clean-up took place on Saturday 4 May, where our project manager Victor Préaux teamed up with GreenLives Hub to clean up the side of a busy highway in Malabo, the country's capital.

The local NGO regroups volunteers from around the city every two Saturdays to raise awareness about local waste management issues. Together with a group of 30 people, we collected over 22 medium-sized bags and 15 big bags containing all kinds of waste: from water bottles and drinking cans to packaging and organic waste, a wheelchair, and car parts!

While it is sad to see all the trash around the city, these young folks are dedicated to showing they care about their city and its environment! It is their determination and dedication that will make changes happen!

## EU ministers of environment approve new the EU Nature Restoration Law

Under discussion for a long time, the nature restoration law was at last approved by the European ministers of the environment on 17 July, four months after the green light from the European Parliament. Long in doubt, its approval follows a positive vote by the Austrian minister of environment, tipping the majority in favor of restoring our nature.

What does it contain? The law aims to bring healthy ecosystems back to Europe and provides a set of ambitious targets, it aims to fill gaps and reinforce efforts to establish a healthy and resilient ecosystem. At least 20% of the EU's land and maritime areas by 2030, and all ecosystems in poor to bad quality by 2050 will need to be restored and protected. Measures include the extension of natural habitats to stop biodiversity loss and to bring back species and reverse the decline of pollinator populations. Other efforts include concrete targets for forest, marine, urban and agricultural ecosystems. Specific measures can be found here.

#### **Update on the Global Plastics Treaty Negotiaitons**

The 4th session of the Intergovernmental Negotiating Committee (INC) took place in Ottawa at the end of April. The negotiators came to some agreement but essential discussion points such as the reduction in the production of primary polymers remain unclear. They agreed to include the development of a list of products and chemicals of concern, and standard design requirements to improve recycling capabilities.

Countries have also agreed to organize formal meetings between INC-4 and INC-5 which could see the pushing through of lists of harmful and avoidable plastic products and chemicals, the product design for reuse and recyclability. These meetings must be used to continue the work of INC-4 and present real progress at the next meeting in South Korea.
